## Keynote Speakers

**KBI Director Tony Mattivi** has served as a federal prosecutor for over 20 years, prosecuting drug trafficking, violent crime, racketeering, organized crime, gangs, money laundering and terrorism cases.

Director Mattivi will discuss KBI initiatives and the fight against fentanyl. Additionally, Director Mattivi will discuss the prosecution of terrorism cases through his own experience working for the U.S. Department of Justice's Regime Crimes Liaison Office in Iraq.

**Christopher McFarlin, JD, MS** is a former Deputy State Prosecutor from Little Rock, Arkansas. He has over 18 years of law enforcement and legal service to our criminal justice system and currently serves as a Sergeant over the training, S.R.O and reserve units for a local police department.

Mr. McFarlin will be discussing Advanced Search & Seizure. This course is designed for all law enforcement officers who have some experience in search and seizure law. The instruction is eye-opening, fast-paced and uses case studies to explain the development and the current status of the legal aspects of searches and seizures.

## Breakout Sessions

**DNA Preservation & Machine Gun Conversion Devices** - Clinton D. Westgate is an ATF Special Agent. He will present on evidence preservation in searches and machine gun attachments or switches, which have been seen more often by law enforcement.

**Drug Identification** - Bryson Wheeler has been a DEA Special Agent for eight years. He has been assigned complex investigations and will focus on Drug Identification in Searches. His breakout will continue in his second session. This is not a repeating breakout.

**Exigent Search and Scenerios** - Joel Cromwell is a Post-Conviction Supervisory U.S. Probation Officer for the District of Kansas. His breakout session will discuss exigent Searches and scenarios an officer may find themselves in.

**Fentanyl Awareness** - Justin Hoffman is a Post-Conviction Supervisory U.S. Probation Officer for the District of Kansas. His breakout session will focus on the dangers of fentanyl.

**Narcotics/Firearms and Electronic Searches with K-9's** - Shaun Margul is a U.S. Probation Officer Specialist in the Eastern District of Missouri. He has thirteen years' experience handling a patrol/narcotic K9 and has been on the Special Response Team for 7 1/2 years. He will discuss utilizing K-9's in searches for various items and the necessary details for implementing a K-9 program in your district.

**Officer Safety Considerations in Surveillance** - Zane Hake is a Team Leader for the USMS Kansas Fugitive Apprehension Task Force. Nate Staab is a Deputy U.S. Marshal for the USMS' Kansas Fugitive Apprehension Task Force (KFATF). He currently serves as a USMS Tactical Training Officer (TTO), Use of Force Instructor and Less than Lethal Instructor. Together they will discuss Surveillance and Intelligence Gathering in Non-Permissive or Rural Environments. They will also lead discussions on Officer Safety Considerations.

**Surveillance Tips and Tricks-** Koda Hendrix is a Supervising U.S. Probation Officer in the Eastern District of Missouri. She oversaw the district's surveillance program & EMOSTA for fifteen years. Grant Sneed is a U.S. Probation Officer Specialist and Surveillance Coordinator for the St. Louis Division. They will discuss techniques for remaining undetected during multiple types of surveillance such as impromptu community observation, highly organized physical surveillance, and pre-search surveillance. Additionally, topics taught during the Eastern Missouri Surveillance Training Academy (EMOSTA) will be discussed such as the legalities of community observation, how districts can develop community observation teams, and navigating difficult environments during community observation.

**Tactical Medicine** - Justin Hoffman specializes in Tactical Medicine and is a nationally registered Advanced EMT. This breakout will give you practical tactical medicine application techniques.
